ELECTIVE: FOREIGN LANGUAGE – TUTORIALS

The subject aims to develop four language skills in students: listening, reading, writing, speaking. Students will be introduced to the knowledge of the organization's functioning in an international cultural context, taking into account cultural differences.

They will learn about the theory and practice of the functioning of political parties, the subject will also allow them to jointly determine the place of the party on the institutional and axiological level of the political system. Students will gain skills in recognizing the strategies and programs of political parties, the rules of the party system, ways of implementing social interests through political parties and party systems.
