**ZDW: Fundamentals of philosophy for administrativeists, political scientists, and lawyers – lecture** **2 ECTS**

### **Constitutional law – lecture**

The aim of the course is to learn about the origins and the process of shaping state law, which then turns into a coherent system of laws and legal acts regulating the activities of the state and its authorities. This is achieved by getting to know the process of shaping power divisions and assigning to each of them appropriate bodies and the appropriate scope of competences. As a result, the education process will also make it possible to learn about the principles of modern constitutionalism.

### **Methodology of law and political science research– lecture**

The course "Methodology of Law and Political Science Research" provides an in-depth analysis of research methodologies and strategies unique to the disciplines of political science and law. Students will gain knowledge of different data collection techniques, analytical frameworks, and qualitative and quantitative research procedures. Important subjects including research design, developing hypotheses, reviewing the literature, analyzing and interpreting results are covered in the course. There is a focus on applying research approaches to actual legal and political challenges as well as ethical considerations. Students will have the knowledge and abilities needed to carry out thorough and significant research in their fields by the end of the course.

Students in this course work on practical research projects that apply the techniques they have learnt in the following lecture. Students learn how to create research projects, formulate research questions, choose suitable methodologies, gather and

Students study subjects related to political science and law, either alone or in groups, which helps them hone their research, critical thinking, and problem-solving abilities. Students work with teachers to refine their understanding of research methods and applications by participating in discussions and receiving feedback on their projects. Students will have finished a research project at the end of the semester, showcasing their capacity to carry out methodologically sound legal and political science investigations.
